**7. VOORLEGGING VAN FINANSIËLE STATE 2022 EN BEGROTING VIR 2023/PRESENTATION OF FINANCIAL STATEMENTS FOR 2022 AND BUDGET FOR 2023**

Attie het almal bedank wat die Unie bygestaan het deur moeilike finansiële tyd wat veroorsaak is deur die verlies aan gebruik van die Unie se trok en sleepwa as gevolg van 'n ongeluk. Hy bedank ook die Unie se bestuur vir hulle harde werk die afgelope jaar.

Freddie bespreek die finansiële verslag en noem dat met in aanmerking van die skade wat die Unie gelei het, ons nogtans R45 000 wins gemaak het. Freddie lê ook 'n begroting voor vir 2023 indien die vlieggewigte onveranderd bly – Verwag 'n verlies van R57 000. Freddie het ook verduidelik wat die stand met die NPO aansoek is - dit is 'n lang uitgerekte proses.

Attie thanked everyone who stood by the Union during the difficult financial time caused by a road accident with the resultant loss of our transport system. He further thanked the Union committee members for their hard work during these trying times.

Freddie discussed the financial statement and mentioned that even when taking into account the damage sustained, the Union was still able to show a R45 000 profit. Freddie also presented a proposed budget for 2023 without any changes to the flying costs – Expect a loss of R57 000. Freddie also explained what the progress is regarding the NPO application – It is a long time consuming process.

**14. GAUTENG COMBINE WEDVLUGTE/GAUTENG COMBINE RACES**

Die voorstel is dat die VPU aan nege (9) van die twaalf (12) "combine" naweke gaan deelneem. Gedurende die 2022 seisoen het die VPU die beste van al die unies in die "combine" gevaar.

The proposal is the the VPU will compete in nine (9) of the twelve (12) combine race weekends. During the 2022 season the VPU fared the best out of all the unions in the combine.

**15. TERUGVOER VAN SANPO VERGADERING/FEEDBACK FROM SANPO MEETING**

SANPO is besig met 'n webblad waar alle uitslae gelaai moet word, ringbestellings sowel as ander voorraad benodighede geplaas moet word.

Attie gave feedback of the SANPO Annual General Meeting that was held in Cape Town.

He also mentioned the names of the VPU members who received honorary awards and congratulated them.

Pigeon fanciers are encouraged to participate in pigeon shows, the next show will be on the 5 to 6 May which will be held in Trichard in Mpumamanga.

SANPO is busy developing a website where all race results are to be loaded, marking ring & other provision's orders must be placed. The rules regarding doping have changed – awaiting new manual.

Van volgende jaar af moet lede wat net 'n (10/10) span wil vlieg en nie 'n pensioenaris is nie aansoek doen by die Unie om daaraan deel te neem.

Ledegelde asook 1ste van 4 vervoerpaaieimente moet teen einde April 2023 betaal word, 2de vervoerpaaieiment einde Mei, 3de paaieiment einde Junie en 4de paaieiment einde Julie. Beginners en nuwe lede mag slegs jaaroud duiwe vlieg indien hulle dit verkies.

Note there is a limit of two (2) teams which can be flown to one residential stand and each team must be separately registered.

As from next year members who want to fly a (10/10) team and who are not pensioners must apply to the Union for permission to do so. Membership fees as well as the 1<sup>st</sup> of 4 transport installment must be paid by end April 2023, 2<sup>nd</sup> transport installment by end May, 3<sup>rd</sup> installment by end June & 4<sup>th</sup> installment by end July. Beginners and new members are allowed to fly only a young bird tem if they wish to do so.

## **17. STAND VAN VERVOER / STATE OF TRANSPORT**

Die "perd" is al reggemaak maar daar is volgens Robbie Lambie seker nog so twee weke se werk op die sleepwa wat gedoen moet word. Die duiwe sal in die vervolg pal toegang tot water op die trok hê selfs wanneer die trok beweeg. Kameras gaan in the trok en sleepwa geïnstalleer word en sal gemonitor word. Die versekering het die totale koste van die "perd" se herstel gedek maar dit blyk dat die sleepwa ± R40 000 onderverseker was.

The "horse" has already been fixed and according to Robbie Lambie there is still about two weeks of work outstanding on the trailer. The pigeons will in future have permanent access to water in the truck even when in transit. Cameras will be installed in the horse and trailer and will be monitored. The insurance covered all the repair costs to the "horse" but it seems that the trailer was under insured by about R40 000.

## **18. MANDJIE TOEDELING/BASKET ALLOCATION**

Die mandjie-indeling sal gedoen word nadat die eerste betalings ontvang is.

Basket allocation will be done once the first installments have been received.

## **19. VERBODE MIDDELS EN TOETSINGSKOMITEE/PROHIBITED SUBSTANCES AND TESTING COMMITTEE**

Toetse vir die gebruik van verbode middels sal weer gedoen word maar daar moet net gemeld word dat die toets toestelle duurder geword het.

Doping tests will again be conducted this year but it must be mentioned that the price of the test kits has increased.

## **20. ITEMS ONTVANG VANAF KLUBS ONTVANG/ITEMS RECEIVED FROM CLUBS**

### **20.1 VANDERBIJLPARK POSDUIF KLUB**

Deelname aan die TRPF motorwedvlug rakende inskrywingsgelde en inskrywingsvorms. Alle TRPF motorwedvlug betalings moet asb in die VPU se bank rekening inbetaal word. Daar is ook 'n aparte vorm wat ingevul moet word, en moet aan die Unie tesourier & wedvlugsekretaris gestuur word.

All payments for the TRPF car race must be paid into the VPU bank account. There will also be a separate form which must be completed and sent to the VPU treasurer and race secretary asap.

### **20.2 EMFULENI EN HEILBRON**

Beskikbaarstellingsdatum van VPU merkringe – Dit beïnvloed “one loft inskrywings”. Die Unie sal ZA ringe bekom en beskikbaar stel vir lede wat aan die genoemde wedvlugte wil deelneem. Dit sal verhoed dat vroeg geringde duiwe aan jaaroud wedvlugte deelneem teen duiwe wat ouer as die VPU geringde duiwe is.

The date on which the VPU ID rings become available has a negative effect for members who want to participate in “One Loft Races”. The Union will obtain ZA rings and make them available to members who want to partake in the mentioned races. This will prevent them being basketed in yearling races to compete against much younger pigeons.

### **20.3 EMFULENI**

#### **Moontlikheid van “Sprint” wedvlugte/Possibility of Sprint races**

Daar sal gekyk word na die moontlikheid van die aanbied van 'n derde wedvlug na die afloop van die 13 weke se oefenwedvlugte.

Die duiwe sal nader gebring word en later gelos word. “Detail” moet nog uitgeklaar word. The possibility of arranging a 3<sup>rd</sup> race after the completion of the 13 weeks of training flights is being looked at. The pigeons will be brought closer and liberated later. The detail must still be clarified.

Toestemming om GPU geringde duiwe wat deelneem aan GPU geldwedvlugte as addisioneel tot die lid se gewone span te mandjie, maar sal nie in die VPU uitslae verskyn nie. Die saak is bespreek en goedgekeur mits die duiwe op combine wedvlugte gemandjie word.

Request for permission to basket GPU rung pigeons which participate in GPU money races in addition to the fanciers normal team, but will not be considered for the VPU results. The issue was discussed and approved, as long as the pigeons are basketed for combine races.

## **21 ALGEMEEN / GENARAL:**

POKKE & PARAMYXO – Alle duiwe moet met 'n gerigestreerde entstof geënt word. Inentingstertifikaat moet in duplikaat ingevul word en ingedien word voor of tydens die

eerste aand van inkorwing. Dr Ockie Botha is besig om 'n nuwe entstof te ontwikkel wat 'n teenmiddel is vir die Pakistan variant van die Paramyxovirus. Dit sal binnekort beskikbaar wees. Attie vra dat die duiweboere Dr Ockie ondersteun want nie net is hy SANPO se veearts nie maar hy doen baie ontwikkelingswerk met duiwe medisyne.

POX & PARAMYXO – All pigeons must be vaccinated. Vaccination certificates must be completed in duplicate and handed in at or before the first night of basketing. Dr Ockie Botha is busy developing a new vaccine which will be effective against the Pakistan variant of the Paramyxovirus. It should be available shortly. Attie asked that the pigeon fanciers support Dr Ockie because not only is he the SANPO vet but he also does development work with pigeon medicines.

Luiz Almeida is gevra om kortliks te beskryf hoe hy die gebruik van GPS aan die duiwe sport in die vroeë 1990's bekend gestel het.

Luiz Almeida was asked to give a brief description of how he introduced the use of GPS to the pigeon sport in the early 1990's

Indien 'n lid iets wil stuur of ontvang via die duiwe unie trok, moet die lid eers toestemming vanaf die unie bestuur verkry.

If a member wants to send or receive something via the union truck, then the member must first apply for permission from the union to do so.

Ben van Greunen sal die voorstel van 'n drie duif nominasie op skrif stel en vir LA stuur sodat hy dit kan versprei.

Ben van Greunen will document the proposed three bird nomination and send it to LA so that he can circulate it.


Dit is eenparig besluit dat die "One Loft" wedvlug se duiwe saam met die unie se duiwe gelos mag word op die "combine" wedvlugte.


It was unanimously decided that the "One Loft" race birds can be liberated with the union pigeons on the combine races.
